Terms & Conditions:

The following information is intended to assist in renting a car from Barefoot Services, however please be reminded to carefully read the terms, conditions and contractual details outlined in your rental agreement.

AGE REQUIREMENT:

Minimum age for drivers is:

Age 21 for Scooter and Golf Cart rental

Age 23 for Auto rentals

2 drivers maximum is allowed per Golf Cart and Auto rental

ADD'L DRIVER REQUIREMENTS:

- There is no fee per additional driver
- Rates are quoted in US dollars
- All persons intending to drive the vehicle must declare so at the time of rental and must show a valid driver's license and a valid major credit card and passport.
- If the vehicle is driven by any unauthorized person, the rental agreement is null and void and the full weight of all liability is carried by the principal customer.

CELL PHONES

Rental available for US\$5.00 per day with a deposit of US \$75.00

PAYMENT:

The primary driver shall be the contracted renter from whom payment will be secured. All rental agreements must be accompanied by credit card authorization for the lead driver and all other drivers.

TIRE REPLACEMENT:

Your Adventure may take you well into the countryside

- In the event of an irreparable tire, customers who immediately call Barefoot Services for authorization may be authorized to purchase a replacement tire to be fitted.

- All vehicles are equipped with a spare tire and tools in the event of a flat tire and to save customer's time, customers are asked to put on the spare and to have the flat repaired.

- **24 HOUR ROAD SIDE SERVICE** - Available to all customers via Emergency number above.
- **IN CASE OF ACCIDENT** - Customers are advised to contact the nearest police station (911) and to call Barefoot Services as quickly as possible.
- **ANY OTHER PROBLEMS** - Customers are asked to immediately call the Emergency Number provided

ADDITIONAL HOURS:

If you should exceed the contracted time of return on your rental agreement, Barefoot Services will charge USD 25 per hour up to two hours after which a full day's rental will be charged.

INSURANCE:

DEDUCTIBLE or SECURITY DEPOSIT:

This is not insurance. This is an industry standard amount authorized by renter and Credit Card Company at time of rental but not processed against your account unless there is damage to vehicle when you return it. In the event that the vehicle is returned without any dings, scratches, dents or other damage the card authorization is not pursued.

Barefoot Services does not sell additional insurance, however all our rentals are insured as required by Belize laws.

Renter is fully responsible for vehicle and its damages unless able to prove otherwise.

Other Rental Policies

ALL DRIVERS MUST BE PRESENT AT CONTRACT SIGNING.

General Rental Rules:

- 1) All intended drivers must present valid license at time of rental and must carry said license while operating the vehicle as well as a copy of the rental contract.
- 2) The renter(s) agree(s) there is no refund for unused time.
- 3) Abide by all the rules of the road.
- 4) Do not drive under the influence of drugs or alcohol.
- 5) No driving is allowed on airport runway, private property or restricted areas. Driving on any "beach" is forbidden.
- 6) A surcharge will be levied for any "emergency" calls as a result of carelessness.
- 7) In case of any accident, a report with the local police must be filed immediately.
- 8) Barefoot Services must be notified immediately upon an accident and or malfunction of the rented vehicle.
- 9) Damages or extraneous costs to Barefoot Services rental will be assessed at appropriate time and action against renter will be taken to recover said losses.
- 10) An open credit card imprint (or security deposit form) with varying amounts for each rental type is signed at the time of picking up the rental.
- 11) Any breach/violation of the agreed to contractual rules constitutes an immediate return of the rental to Barefoot Services and an immediate loss of privilege.
- 12) There will be a USD \$15 (For Golf Cart and Scooter) and USD \$250.00 (for Auto) fee applied for failure to return the keys upon rental return and any additional charges or loss associated with the keys not returned. Some vehicle keys are not able to be replaced within Belize.
- 13) There will be a USD \$15 charge for Golf cart steering wheel locks that were issued with the rental.
- 14) A USD \$250.00 FINE will be charge to any renter who allows a child or any unregistered driver to drive the rental. The contract will become void and renter does not get a refund for any unused time.
- 15) Overloading of any rental is strictly forbidden.
- 16) Damages are assessed per day regardless if rental is a full day rental or not.

- 17) Any rental hours after 5:30 PM apply to 24 hr rental rate.
- 18) Lock the steering (Golf Carts) and take the keys at all times.

Reservation/Confirmation Policy

- To confirm any reservation a valid Master Card, Visa credit card is required at booking. Cash deposits are also accepted. A one day deposit is collected for rentals and 50% for charter service.

Cancellation Policy

- A full refund minus 20% administrative fee will be granted if written cancellation is received more than 2 days prior to reserved date. No refund if written cancellation is received 2 days or less prior to reserved date.
- Special Note: No refund if written cancellation is received 7 days or less prior to reserved date in the peak times of Dec 20-Jan 5 and Easter break.
